J&K Base FPO, IREF AND SARVESHWAR FOODS SIGN MOU TO BOOST KASHMIR'S AROMATIC "MUSHKBUDJI RICE" PROCUREMENT

Jammu – November 10, 2025: Sarveshwar Foods Limited's (SARVESHWAR | BSE: 543688 | INE324X01026), today announced of entering into a tri-party agreement for the procurement and distribution of Mushkbudji Rice - a locally produce aromatic rice.

Following this agreement, *Mushkbudji Rice* — the aromatic rice from Jammu & Kashmir — will now be promoted through a new collaborative initiative. This was announced on the sidelines of BIRC 2025.

Three key entities have signed a Memorandum of Understanding (MoU) to explore commercial arrangements for the procurement and promotion of this prized rice variety.
